 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Transparency in Gov-
 - 5 ernment Contracts Act".

1	SEC. 2. DISAGGREGATE DATA ON CONTRACTS AWARDED TO
2	SMALL BUSINESS CONCERN OWNED AND
3	CONTROLLED BY SOCIALLY AND ECONOMI-
4	CALLY DISADVANTAGED INDIVIDUALS.
5	(a) In General.—Section 15(h) of the Small Busi-
6	ness Act (15 U.S.C. 644(h)) is amended—
7	(1) in paragraph (2)(E)(iv)—
8	(A) in subclause (VII), by striking "and"
9	at the end;
10	(B) in subclause (VIII), by adding "and"
11	at the end; and
12	(C) by adding at the end the following new
13	subclause:
14	"(IX) disaggregated by—
15	"(aa) the race, ethnicity,

9	practicable, disaggregate the data required by para-
10	graph (2)(F) for subcontracts awarded to small
11	business concerns owned and controlled by socially
12	and economically disadvantaged individuals by—
13	"(A) the race, ethnicity, and gender, or by
14	the type of entity, as applicable, of the socially
15	and economically disadvantaged individuals that
16	own such small business concerns owned and
17	controlled by socially and economically dis-
18	advantaged individuals; and
19	"(B) whether the small business concern
20	owned and controlled by socially and economi-
21	cally disadvantaged individuals participates in a
22	program under section 8(a) of this title.".
23	(b) APPLICABILITY.—The amendments made by sub-
24	section (a) shall apply only with respect to reports re-
25	quired by section 15(h)(2) of the Small Business Act (15

- 1 U.S.C. 644(h)(2)) after the date of the enactment of this
